ई. निविदा विवरण:- अधिशासी अभियन्ता, विद्युत वितरण खण्ड-द्वितीय, मुजफ्फरनगर के अधीन विद्युत वितरण उपखण्ड-चरथावल, मुजफ्फरनगर के कार्य क्षेत्र के अन्तर्गत ग्राम-कुटेसरा में पुलिस चौकी के पास स्थापित 100 केवीए वितरण परिवर्तक के अतिभारित होने के कारण अतिरिक्त 100 केवीए डबल पोल का निर्माण करना एवं ग्राम-चरथावल में मुस्लिम तगायन मौहल्ला में राशिद के घर के पास स्थापित 100 केवीए परिवर्तक के अतिभारित होने के कारण 100 से 250 केवीए क्षमतावृद्धि करने का कार्य बाह्य एजेन्सी के माध्यम से कराये जाने हेतु कार्य।

These specific conditions shall be read and construed along with annexed conditions to the contract Form (A) modified by the provisions hereof, but if there is any conflict or consistency between the provisions thereof and those contained in the General Conditions of the form (A) The provisions contained in these special conditions shall prevail:

1. RATES:- The rates mentioned in the schedule of quantities and prices are shall be firm.
2. PAYMENT:- 100% Running payment shall be allowed against the work done and verified by the Engineer-in-charge of the work done and verified by the Engineer-in-charge of the work, through cheque on availability of funds.
3. CANCELLATION OF TENDER:- Superintending Engineer,EDC-I,MZN have right reserved to any change/cancellation of tender in Corporation Interest without assigning any reason what-so-ever.
4. CANCELLATION OF AGREEMENT:- The Agreement shall be cancelled in case the contractor does not complete the work as per provisions, security deposited by firm shall be forfeited.
5. EARNEST MONEY:- Each Tender must be accompanied by the Earnest Money in the form of cash deposit through RTGS/NEFT, Which will be refunded in the event of tender being rejected. No tender shall be entertained without Earnest Money. **Cheque/FDR/CDR** will not be accepted against the Earnest Money in any case.
6. TAXES:- GST shall be paid extra if legally applicable.
7. AWARD OF CONTRACT:- The Engineer of the Contract is not bound to accept the lowest or any tender and reserves the right of accepting the whole or any part of the tender without assigning any reason what-so-ever.
8. Security amount is deposited by the contractor will be refunded after 2 months of completion of work or it may be kept for a longer time/period if considered necessary by the Engineer-in-charge.



9. In the event of any accident/casualty during the course of execution of work , shall be the responsibility of contractor. Any payment, compensation thereof shall be borne by the contractor.
10. VARIATION WORK:- The increase and decrease can vary upto 10% of the total work value of the contract as per site requirements. However tendered unit rates shall remain firm upto a variation.
11. All General Conditions of Contract laid down in Form 'A' & Form 'B' of UPSEB/UPPCL/PVVNL shall also be applicable.
12. A penalty @ 1/2% of tender value per day for delay in execution of the work shall be payable by the contractor on the total value of the work not done/late done as per work slip. The maximum penalty livable will not, however, exceed 10% of the value of the order not executed.
13. No T&P will be provided by the department. The contractor shall arrange all the T&Ps. equipments. Welding set, generator set etc. required for carrying out the above work at his own cost.
14. The contractor shall be fully responsible for any loss/thefts/damaged/ accidents the material of the departments and accordingly, he shall have to keep adequate watch and ward to avoid any loss/thefts/damages/accidents etc. to the material of the PVVNL.
15. 100% payment shall be made after completion of pro-data work. The bills in triplicate duly pre-receipted with the original work-slip and photo of the work shall be submitted by the contractor to the Concern Office for payment.
16. The undersigned shall have full right in the interest of the corporation while disposing of the tender that in view of the reputation of the firm, it can dispose of the tender in favor of any firm. In the interest of corporation, the rate and interest of workers will also be taken into consideration while disposing of the tender.
17. For any dispute arising out of the contract, CE, PVVNL, Sre Zone Sre shall decide the dispute and his decision shall be binding on both the parities.
