## **SPECIAL CONDITIONS OF CONTRACT**

These Specific conditioned shall be read and constructed along with annexed conditioned to the contract Form "A" modified by the provisions here of, but if there is any conflict or consistency between the provisions there of and those contained in the General conditions of the Form "A". The provisions contained in these special condions shall prevail.

1. The work Shall be executed by the contractor under the supervisions of Concerning Sub-Divisional Officer under Concerning Executive Engineer.
2. The price are firm and no any other charges shall be paid extra to the contractor.
3. No departmental labor and T&P shall be provided to the contractor by the department.
4. **Rates:-** The rates are to be mentioned in the schedule of quantities and no variation there on shall be allowed in any case.
5. **Security:-** The contactor Performance Guarantee shall be 10% of the Contract Value of the tender specifications and in the form of RTGS/NEFT/DD/Bankers Cheque/BG (from a scheduled bank) only. In any case, the successful bidder shall not be allowed to deduct CPG amount from their running bills and they are required to submit valid & requisite Contract Performance Guarantee.
6. **Penalty:-** ½% penalty per week, subject to maximum of 10% on the total face value of the agreement.
7. **Rejection of defective Works:-** Any defective/inferior quality of work not confirming to specifications, shall have to be redone by the contractor free of cost to the satisfaction of the Engineer-in-charge of the work.
8. **Earnest Money:-** Each tender must be accompanied by the Earnest money in the form of RTGS/NEFT of a scheduled Bank duly pledged in favor of Superintending Engineer, Electricity Distribution Circle, Amroha. The earnest money will be refunded in the event of tender being rejected or after completion of work. No tender shall be entertained without earnest money. Cheque will not be accepted against earnest money in any case.
9. **Taxes:-** All taxes shall be paid extra as applicable.
10. **Award of Contract:-** The Engineer of the contract is not bound to accept the lowest or any tender and reserves the right of accepting the whole or any part of tender without assigning any reason what-so-ever.
11. **Payment:-** Payment shall be made by cheque or RTGS/NEFT, on availability of Fund for the work.
