GENERAL TERMS & CONDICTIONS OF THE CONTRACT-

- 1- Online tenders are invited in two Parts. Part-1 for the earnest money with all Documents (R.C.) and Part-2 for Rate Schedule on behalf of the Corporation. In absence of Part-1 containing earnest money of the required amount, Part-2 will not be opened and the E-tender will not be considered.
- 2- Online tenders will be accepted up to 13-00 hrs by the undersigned and will be opened on the next day at 12.00 hrs. in the presence of tenderers who wishes to be present at the time of opening of the E-tender.
- 3- The E-tender must be accompanied with Earnest money in shape of RTGS/NEFT etc. in favour of the Superintending Engineer, Electricity Distribution Circle, Sambhal. The earnest money in shape of the cheque shall not be accepted and the E-tender will be liable to be rejected.
- 4- The earnest money shall be refunded to the tenderers on the execution of agreement with the successful tenderer. The earnest money of First lowest will be adjusted towards the security.
