2. The tenderers may obtain further information / clarification, if any, In respect of these tender documents from the office of Superintending Engineer, EUDC-II, Sector – 18, Noida.
3. The Intending bidders must be registered on e-tendering portal www.etender.up.nic.in. Those who are not registered on the e-tendering portal shall be required to get registered beforehand. If needed they can be imparted training on online tendering process'. After registration the tenderer will get user id and password. On login tenderer can participate in tendering process and can witness various activities of the process.
4. The authorized signatory of intending bidder, as per Power of Attorney (POA), must have valid class-III digital signature. The tender document can only be downloaded or uploaded using Class-III digital signature of the authorized signatory.
5. E-tenders are invited in two parts (Part-I Techno Commercial Bid and Part II Price Bid) for the above work. Bid document (Tender Specification) is available online on <https://etender.up.nic.in> as per particulars indicated below. Any changes in the Bid Schedule, corrigendum etc. shall also be notified via same website. Prospective bidders are therefore requested to regularly check the website for any updates.
6. Tenderer is cautioned that the tender containing any material deviation from the tender document which consists of NIT, Instructions to tenderers, General conditions of contract, Special conditions of contract, Bill of quantities is liable to be summarily rejected as non-responsive.
7. Unless explicitly stated otherwise in the Tender Document, the contractor shall be responsible for the whole works, based on the Bill of Quantities and payment shall be as per accepted rates based on the activities carried out as in the Schedule of work.
8. The rate quoted by the tenderer shall be inclusive of all duties, taxes (inclusive of GST), fees, octroi and other levies, materials, labour to & FOR transportation of material, Work NOC for all department (Authority, PWD, Irrigation, Horticulture etc.), and labour charges etc.
9. **Superintending Engineer, EUDC-II, Sector -18 Noida reserves the right to accept or reject any or all proposals without assigning any reasons. No tenderer shall have any cause of action or claim against the PVVNL/ Superintending Engineer, EUDC-II, Noida for rejection of his/her proposal.**
10. Tenderers are advised to visit the site before offering their rates.
11. The bidders are advised to keep in touch with e-tendering portal www.etender.up.nic.in for updates. Any corrigendum, addendum etc issued shall be part of this tender document and shall be made available on this e-tendering portal.
12. The SE EUDC 2 Noida will examine the bids to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed, and whether the bids documents are generally in order.
13. The SE EUDC 2 Noida may waive any minor informality, nonconformity or irregularity in a bid that does not constitute a material deviation, whether or not identified by the Bidder in its bid, and that does not prejudice or affect the relative ranking of any Bidder as a result of the technical and commercial evaluation.
14. Prior to the detailed evaluation, the SE EUDC 2 Noida will determine whether each bid is of acceptable quality, is complete and is substantially responsive to the Bidding Documents. Any deviations, conditionality or reservation introduced will be reviewed to conduct a determination of the substantial responsiveness of the bidders bid. For purposes of this determination, a substantially responsive bid is one that conforms to all the terms, conditions and specifications of the Bidding Documents without any material deviations, objections, conditionalities or reservations and complies with all the statutory laws in force as amended from time to time. SCOPE OF WORK:

The Contractor shall be responsible for providing the Cable Fault Locating Machines of appropriate and latest version & specifications along with experienced technician, helpers and driver etc. by their own end for locating the 11 KV & 33 KV Cable Fault on round the clock basis in the Jurisdiction of EUDC-2 Noida Urban/Rural areas both.

Pin pointing within two meter of cable fault, exposing the same in the underground HT cable (33 KV and 11 KV) including cutting of the Faulty Cable, its meggering & sealing of healthy cable.

In addition to locating and pin pointing of cable faults, the contractor shall also be responsible for digging of cable trench of suitable size so as to enable making of cable joints (one or two straight through joints depending on the requirements), it shall also include cutting of the faulty cable in sufficient length.

Road cutting & digging thereof so that cable may be taken out for jointing work. Dressing of road as may be required at various places in Jurisdiction of EUDC-2 Noida. The outdoor/Indoor termination kit and Straight through jointing kits and cable jointer shall be provided by contractor.

WORK SCHEDULE :

- i) The work of pin pointing and locating cable in fault in underground HT cables shall be executed/started by the contractor within one hour of giving call or message to this effect. The contractor may be required to attend more than one fault simultaneously in each division. JE/SDO will call/sms to the contractor about the fault and will keep a record of screen shot of call/message log. Log details will also be maintained by contractor and will be attached with bills produced for payment. For late reporting beyond 01 hours, a flat 5% penalty of the job work will be deducted from the bills of contractor.
- ii) The contractor will dig the cable trench in such a manner so as to avoid any damage to the cable or any other public utilities existing under the ground.
- iii) The fault location shall to be done throughout the entire link to pin point all the faults and making its possible to revive the link in such a manner so that the link under breakdown gets operational within minimum period to time.
- iv) The contractor shall be required to carry out the fault location work for 24×7 in all divisions.
- v) **In the event of inaccurate pin point/exposing the contractor will have to bear the expenditure incurred in locating the fault. For inaccurate pin pointing exposing, a flat 5% penalty of the job work will be deducted from the bills of contractor.**
- vi) The Cable fault locator machine, other tools/equipments and testing facilities etc. shall be provided by the contractor. It shall be responsibility of the contractor to arrange experienced technical staff and labours required for the tendered work at their own cost.
- vii) The contractor shall be fully responsible for safety/Insurance of their gang as for payment of compensation in case of any accident during the execution of the work, including third risk/claim as legally applicable. The engineer of contract shall have full right for recovery against such claims/compensation from the contractor.
- viii) The contractor will complete the work within 2 hours after reporting at site of fault. For delay in completing the work a penalty @ 5% of the job work per hour for first two hours and @ 3% for subsequent hours upto a maximum of 25% of the job work will be deducted from the bills of the contractor.
- ix) Any damage or loss of public property/Board's materials shall have to be borne by the contractor.
- x) JE/SDO of concerned area/divisions will have to ensure proper shutdown & supervise the work.

Responsibilities of Contractor:-

1. The contractor arranges and execute the Construction of New HT/LT Line for giving New Electricity Connection to the Consumers and line shifting work under Full Deposit Scheme in the areas of EDD-Greater Noida. Work Will be completed in One Day or decided by E.E.
2. The contractor is required to make them fully conversant with the job required and the work shall be executed as per general conditions of the tender specification contract.
3. The contractor shall be supplying, erecting, testing & commissioning of all materials and equipments not mentioned specifically in the scope of works but required to complete the job in all respect, except excluded specifically for which no extra payment shall be made.
4. The Contractor shall have to arrange all carriage facility including transportation cartages, man power, T&P etc.
5. Any type of NOC (Forest Deptt., Noida/Gr.Noida/Yamuna Authority any other Govt./PSU/Private areas etc.) for the completion of following work will be arranged by the bidder itself only, Department will not be liable for these NOC.
6. Tenderes are advised to visit the sites/Areas of divisions before offering their rates.
7. Illumination/Lighting of working site shall be in the scope of contractor. Nothing shall be paid by the PVVNL.
8. JV's firms are not allowed for the tender.
9. Safety of Man & Material shall be ensured by contractor.
10. The contractor shall ensure that the work is carried out as per NGT Norms/Standard and in such a manner that all premises always look Neat & clean, Similarly, the waste disposal is also carried out in totally sealed manner without affecting the Environment.
11. Contractor shall have to deposit a security Amount @ 10% of the value of Awarded Contract in the form of FDR/PBG pledged in favor of SE EUDC-2 NOIDA at the time of agreement/before the agreement, validity of Security amount shall be 01 Year. Other Terms & Conditions:-

1. The rates are FOR destination. Labour and T&P/hydra/crane etc. shall not be given by the department.
2. Any other misc. work required for proper completion of work shall be done by the contractor.
3. Any losses and damage during the transit of work shall be charged from the contractor.
4. The above work shall be done under the supervision of EE/SDO/JE concern.
5. Bidder will have operate with fault locating machines as required in different locations simultaneously in each divisions round the clock.
6. Fault locating machine in time of need will have independent manpower to operate.
7. The contractor will submit MIS with submission of bills.
8. "As per section 171 of CGST Act 2017, any reduction in rate of term on supply of goods or services or the benefit of input tax credit shall be passed on to the recipient by way of commensurate reduction in prices. Hence supplier/manufacturer to ensure to pass the benefit of reduced prices of PVVNL., Further price quoted by supplier/manufacturer is subject to scrutiny under above section."
9. Welding set, generator set etc. required for carrying out the above work at contracted own cost.
10. The contractor shall be fully responsible for any loss/thefts/damaged/accidents the material of the departments and accordingly, he shall have to keep adequate watch and ward to avoid any loss/thefts/damages/accidents etc. to the material of the PVVNL.
11. Shifting/Loading/Unloading of New/Old cable drum/cable pieces from store to site and back by using the crane and truck of requisite capacity will be done by the contractor.

12. Un-rolling of cable drum, laying of new cable in lieu of faulty cables for providing/repairing cable joints etc. as required will be done by the contractor.
13. During the period of work in progress, the contractor shall have to provide lighting arrangement; sign board etc. or necessary precautionary arrangement so that accident/ damages/ losses to the public/ manpower of the contractor/ department etc. are avoided.
14. The contractor shall be fully responsible for any accident/loss to the persons(s) working with/under him and shall have to pay compensation in accordance with the prevailing rules & regulations of Govt/PVVNL.
15. Proper skilled staff included Supervisor capable for execution of the above work shall have to be arranged by the contractor. The safety of labour while at work shall be the responsibility of the contractor and any compensation to be paid to them on any account, whatsoever, shall also be responsibility of the contractor UPPCL/PVVNL shall not be liable for any such compensation etc.
16. The agreement will operate for the period of 6 Months or till the agreement/work quantity completed.
17. All type of Jointing kits and straight through will arrange by contractors as per BOQ rate schedule of the tender.
18. All General Conditions of Contract laid down in Form 'A' & Form 'B' of UPSEB/UPPCL/PVVNL-Standard Terms and Conditions shall also be applicable and all conditions shall be acceptable of the contractor.
19. Manpower for loading, unloading, laying different size of cable shall be provided by the contractor..
20. Checking of cables by meggering and Hi-pot after jointing shall be in the scope of contractor.
21. D.L.P. if any rectified joints shall be in the scope of contractor.
22. All the work associated with finishing such as welding, patching, grinding complete in all respect shall be carried out by contractor for which nothing shall be paid extra.
23. Income Tax shall be deducted from the bills of the contractor as per rules enforce at the time of payment.
24. If the contractor fails to execute the work within the stipulated period, the order placing authority reserve the right to get the work done departmentally or through any other agency. 26. The agreement can be terminated by the Engineer of the contract at any time without any notice in the event of un-satisfactory performance of the contractor. This is however, without prejudice to the other terms & conditions of the agreement.
27. The charges for Road cutting, Forest Clearances charges, land lease charges or from any other agency which are required to complete the work shall be paid by the contractor.
28. Any loss or damage to any of the public utilities shall be repaired by the contractor at his own cost.
29. The Contractor shall make adequate Arrangement for proper Handling of Material to avoid any Damage/ Loss/Accident etc of any kind and Damaged and Removed material and Spares parts will be retained by department.
30. The contractor shall have to execute the work within the stipulated time as provided in the order (work-slip) to be issued by the competent authority.
31. Cable Jointing Kits, bricks, cement, coarse sand, river sand, brick ballast, stone ballast, all type of clamps, nuts & bolts and other petty items etc. if required for execution of work, which will be arranged by the contractor at his own cost.
32. The Proper Shut down will be given as required by the Contractor time to time as per site/system Requirement and Availability by the SDO/JE of the Concern Area.
33. Manning of site by guard shall be in the scope of contractor.
34. Work may prolong due to bad weather condition or power Block constraint. Contractor has to negotiate with the prevailing conditions. Nothing will be paid extra.
35. While executing work, damage if any to the property/asset of PVVNL/other agency shall be compensated by the contractor.
36. Consumables like warming tape, HDPE pipes etc. required for executing of job shall be arranged by contractor.
37. Payment shall be made through running bills as per progress of work by the concerned divisions where work was done/as per BOQ Qty. approved by the Contract of Engineer after submission and approval of MIS report by Contract of Engineer.
38. The payment shall be made subjected to submission of jointly signed report of PVVNL Engineer In charge & representative of firm.
39. Joint report with concerned officer / staff shall be made in triplicate duly signed by field staff and concerned officer. Bill along with copy of joint report shall be submitted to concerned EE (Distribution) for verification and processing the bill for payment and it will also be submitted to Contract of Engineer by Monthly Basis.

40. All the spare parts required to be replaced by the new shall be provided by the contractor under 12 months warranty period and the entire new material shall have to deposit a security Amount @ 10% of the value of Contract in the form of FDR/CDR pledged in favor of EE OF CONCERNED DIVISION/AREA and shall be returned/refunded after 12 months warranty period.
41. The material shall be inspected by the department at manufacturer works unit before supply.
42. The contractor will purchase the material as per PVVNL approved GTP/technical specification.
43. The quantity of cable fault/digging of trench may vary upto the extent of $\pm 50\%$ on either side on same rates, terms & conditions for which no claim of the contractor will be entertained, deviation of work will be allowed after permission of Contract of Engineer, EUDC-2, Noida. Depending upon the site conditions, the individual quantity of any item / work may vary up to $\pm 50\%$.
44. Videography or Photography of site shall be done by the contractor before start the work and after its completion, cost of which will be borne by the contractor.
45. The Work bifurcated for divisions individually by SE EUDC -2, Noida AT THE TIME OF AGREEMENT and He has reserves the right that the work/qty of divisions will be modified as bifurcated, Prior Permission will be given by the contract of engineer to firm's for change of Qty./work of in the Division.
46. The firm shall procure and installed the materials in the field of PVVNL APPROVED (Denson/3M/Raychem) manufactures and as per GTP of PVVNL.
47. All those petty materials not appearing in the prices schedule but are required to complete the work as per Bill of Quantity / Price Schedule, shall have to be arranged by the contractor at his own cost. Similarly any work activity not specifically indicated but is required for systematic execution of job as per Bill of Quantity / Price Schedule, shall also be done by the contractor for which no separate payments shall be made.

48. The work will have to be carried out strictly as per Indian Electricity Rules & RESPO specification and guidelines and relevant drawings, subject to modification as per site conditions.
49. Warranty Period of installed/supplied material: 12 (Twelve) months.
50. Material purchased by the Contractor/Agency/firm shall be inspected by the competent committee of PVVNL before supply of material for which an inspection shall will be made by the contractor to competent committee authority P.V.V.N.L. through S.E., E.U.D.C-II, Noida
51. Managing of site by guard shall be in the scope of contractor
52. The Contractor shall provide all the facilities (machine & tools etc) to inspecting team in order to check the quality of work. All the expenses shall be borne by the contractor for quality check work. No extra charge will be claimed by contractor.
53. All those petty materials not appearing in the prices schedule but are required to complete the work as per Bill of Quantity / Price Schedule, shall have to be arranged by the contractor at his own cost. Similarly any work activity not specifically indicated but is required for systematic execution of job as per Bill of Quantity / Price Schedule, shall also be done by the contractor for which no separate payments shall be made. Any other misc. work required for proper completion of work shall be done by the contractor.
54. Payment shall be made through running bills as per progress of work by the concerned divisions after submission MIS report. (Running bill will be paid 50% after 80% contract work completion.)
55. Process for Payment of work and material shall be done by the Concerned Executive Engineer of the Division where work was done as per departmental norms after the complete execution of work/entire project & submission of executed estimate and after getting satisfactory report and measurement in all respect by concern J.E. and S.D.O. Payment will be made by the PVVNL HQ after availability of funds.
56. Income Tax, TDS, GST-TDS, Labour Cess and all other taxes shall be deducted from the bills of the Contractor as per rules prevailing of Central Govt. at the time of payment.
57. In case it is found that the tender as submitted forced/fictitious documents along with the tenders, his offer will be cancelled and earnest money will be forfeited. Also the Contractor can be black listed for tendering for work.
58. The payment of royalty levied by state/central/other institutions on minerals and other conditions issued time to time by the Government shall be the responsibility of the contractor. The authority shall be free to take appropriate action without any notice in case of non compliance/ non submission of documents of the said payment.

59. The contractors have to furnish his rates including Labour Cess @ 1% the same shall be deducted from the bills of the contractor. The royalty charges levied by stats/central govt. on & other terms 2 conditions issued time to time by govt. shall abide by minrally shall be paid by contractors and its proof shall have to be submitted to Noida.

60. Fund Head for ERP: O&M.

61. The Tender Work will be bifurcated/allotted within Two firms / more than two firms on L-1 quoted rates as required for timely completion the works by the SE EUDC -2, Noida at the time of agreement.

62. The Agreement can be terminated by the Engineer of the Contract at any time without any prior notice in the event of un-satisfactory performance of the Contractor. This is however, without prejudice to the other Terms & Conditions of the Agreement.

63. If the Contractor fails to execute the work in the stipulated period then the departmental action may be taken (Blacklist, Debarred etc.) against them by the Engineer of Contract. The contractor shall have any cause of action or claim against the Engineer of Contract.

64. Notwithstanding the agreement executed with the Contractor, the Engineer of the contract always reserves the right to get the work done by department or through any other agency. The Contractor shall have no objection and claims over such work.

65. For any dispute arising out of the Contract, Chief Engineer, Noida Zone, Noida. Shall final Authority to Decide the Dispute and his Decision shall be binding on both the Parties.
