PRE-QUALIFYING CONDITIONS FOR TENDERERS (PQR)

Technical & Financial Pre Qualifications :-

The Tenderer must fulfill the following technical /financial requirements -

1. The tenderer should produce experience statement showing the Name of organization, name of work, DOS, DOC, ADC, Agreement Value, Executed Value, Penalty and experience of officer with contractor during the execution of work executed in Central/State Govt. Depts. and that should not be issued by officer below class-I rank (shall be produced in Part-I).
2. Tendering firm should have experience of having successfully completed similar nature works during last 7 years ending last day of month previous to one in which applications are invited and should be either of the following (shall be produced in Part-I):-
 - A. Three similar* completed works each costing not less than the amount equal to 40% of the estimated cost. or
 - B. Two similar* completed works each costing not less than the amount equal to 50% of the estimated cost. or
 - C. One similar* completed work costing not less than the amount equal to 80% of the estimated cost.

(Note:- Agreement/work order copy will not be considered as experience)

GENERAL ABILITY REQUIREMENT:-For Intimation To The Contractor only:-

- a. Bidders shall not be under a declaration of ineligibility of corrupt and fraudulent practices by the Central Government, the State Govt. or any Public Undertaking, autonomous body, authorities by whatever name called under Central and State Govt.
- b. Any bidders having criminal records is not allowed to participate in the bidding process. Any person who is having criminal cases against him or involved in the organized crime or gangster activities or Mafia or Goonda or Anti social activity are strictly prohibited to participate in the bidding process. If it is established that any bidder has criminal record his bid shall be automatically cancelled.
- c. Any bidder who is an Advocate & Registered with any State Bar Council shall not be allowed to participate in the bidding. If it is established that the Contractor is registered with the State Bar Council, his bid shall be automatically cancelled.
- d. Joint ventures are not allowed.
- e. If Agreements/bills are signed by any person behalf of contractors/firms, he/she must have power of attorney from the agency. He/ She will have to put in signature as per PAN or signature certified by Bank.
- f. In case of any document submitted by bidder is found to be false, firm/contractor shall be blacklisted from the corporation.

(Tenderer will not be considered for Part-2 opening in case of any required document as below is not provided along with Part-1 documents. Affidavit will not be considered against any required document as below. All the documents should be self signed or digitally uploaded.)

- A. Digitally uploaded UTR No. & other detail for tender cost & earnest money or mention UTR/Reference no in instrument No column properly while uploading documents or otherwise decision will be taken on the basis of account statement.

(Note:- Earnest Money & Tender fee must be deposited in the mentioned account upto the date of bid submission)

- B. Average Annual financial turn over during the last 3 years ending 31st March of the previous financial year, should be at least 30% of the estimated cost for which practicing C.A. approved Turn Over Certificate (Turn Over certificate must have UDIN of CA) has to be submitted (shall be produced in Part-I). If balance sheet/Turn over Certificate of any financial year is missing or not produced it will be taken as zero.
- C. ITR of Last 3 Years Shall be Submitted by the Contractor (2020-21, 2021-22 & 2022-23).
- D. Valid character certificate issued by D.M/S.P office required for all firms/contractor while for partnership firm and Pvt. Ltd., firm character certificate of every partner/Director will be required. Character certificate shall be valid on date of opening of Part-1 of tender.

(Tenderers should submit on rupees 10 Non-Judicial Stamp Paper an affidavit (Duly Notarized) in favor of S.E., ECDC GZB in given format.)
