1. No need to send/deposit hard copy of any document related to tender in this office.
2. All required documents such as GST, PAN no. experience etc as applicable are check in all respect online first of all the Bidder/Contractors then financial part of successful Bidder/Contractors are opened. The bid of Bidder/Contractors, whose documents are not complete, will not considered and shall be rejected
3. The tender fee amount (non refundable) and EMD amount Should be transferred by RTGS/NEFT in office bank current account no. **2867002100017563**, Punjab National Bank, Moradabad Gate Chaudasi, IFSC- **PUNB0286700** other transaction mode shall not be accepted and tender will liable to be rejected.
4. The earnest money shall be refunded on execution of agreement (first lowest will be adjusted towards the security).
5. Conditional tender shall not be accepted and will be rejected out-right.
6. The quantity of material/distance given in the schedule of contract may vary by 10% on either side.
7. Stock material required for the construction work shall be provided by the department. All the line material will be supplied by the department. Responsibility of work transportation of material from different stores to site of work and supervision of work to its successful completion will be that of contractor.
8. The successful tendered will have to ask his own arrangement for the carriage of material as above at his own cost and no T & P required for the said work shall be supplied by the department.
9. The work will be carried out in accordance with the direction and design given by the representatives of the Corporation and construction manual and instructions. After completion of work, the site will be inspected by the representatives of the Corporation as may be designated from time to time. If any defect found, the contractor will have to rectify the segment his own cost. If they fail to do so, the Corporation will have liberty to carryout work to remove such defect and deducted the expenses so incurred from the contractor's bill.
10. In case the contractor fails to complete the work within the specified period, the remaining work shall be got carried out by some other out-side agency and completed and the difference of the cost which may have to be paid in excess by the department shall be recovered from the contractor and the agreement will be terminated on this account.
11. The undersigned reserves the right to reject the tender without assigning any reasons thereof.
12. Theft of material from the site will be responsibility of the contractor and the cost of the material stolen shall be liable to be received from the contractor.
13. The tender is liable to be rejected if the contractor fails to quote his rate online in the BOQ schedule attached with the tender.
14. The Successful tender will be present in the office of the undersigned to execute the agreement within the period as specified by the undersigned separately from the date of issue of acceptance to this office.
15. Disputes if any will be settled by the undersigned. In case of non settlement of dispute the matter shall be referred to the Chief Engineer, Moradabad Zone Moradabad and decision of the Chief Engineer, Moradabad Zone Moradabad shall be final and binding on both the parties.
16. The contractor will make proper request to the concerning Sub-Division officer for taking the shut-down as and when necessary and the department will not be responsible for any type of mishap-panning/accident takes place during the course of completion of the work by the contractor.

17. Payment for individual work will be made after its satisfactory completion and check at site.
18. A penalty of ½ % per week subject to the maximum of the 10 % of the total value of the work for the period in which the work remain incomplete shall be levied and deducted from the bill of the contractor in case of delay of work within the stipulated period.
19. The amount of the security shall be deposited by the contractor after acceptance of the tender for the total amount of the work before execution of the agreement.
20. The Contractor shall be responsible for the proper handling of the materials any damaged of the material shall be the responsibility of the contractor and the cost thereof shall be recovered from the contractor
21. In absence of tender fee, EMD and all the required other necessary documents, financial part will not be opened and the bid will not considered.
22. The amount required for carriage of material shall be paid by the contractor.
23. Line material and transformer, supports etc shall be carted by the contractor to the contractor.
24. The contractor will be fully responsible for labor, He will comply on the corporation work that may be entrusted to him from time to time and he will be liable to meet all requirements of the laws/rules covering employment of the labor and their safety at work.
25. The contractor will take care that while construction of lines, the electricity rules are followed in respect of clearance safety and sag etc The sag should be as per is and the satisfaction of the representation of Corporation.
26. The Corporation will not be responsible for stoppage of work whatsoever the reason may be.

The contractor will be issued material by the Corporation representative for such job which he will acknowledge and balance will be returned to store immediately after completion of each work for which the material has been issued. The contractor will be responsible for safe up-keep of the material issued to him till corporation's representative and the cost of un-returned material will be recovered from the contractor at the double of issue rate.
