## **TERMS AND CONDITIONS**

1. The contractor shall be responsible for any theft, accident, damage if occurs during execution of work.
2. Only GST shall be paid by the department extra if legally applicable as per Govt. rules.
3. The safety of staff and labour shall be arranged/provided by making necessary arrangement by the contractor at the work site. The PVVNL shall not be responsible for any damage arising there during execution of work. The staff insurance charges if any shall be borne by the contractor.
4. The work shall be executed as per conditions given in standard from 'A' of UPPCL except the condition modified under the special conditions.
5. Income Tax shall be deducted from the bills of the contractor as per provision of Income Tax act.
6. The measurement shall be taken by one junior engineer deputed by the concerned Sub-Divisional officer.
7. No labour below the age of 18 Year will be deployed by the contractor at work site.
8. If any accident, arises the compensation is to be given to any workman, it will be paid by the contractor himself. Department will not be responsible for any compensation. However, if as per existing Law such compensation is paid by the department, it will be deducted from contractor's bill.
9. Quantity of any item may vary upto any extent.
10. 10% variation of total amount of tender shall be allowed in this contract.
11. All disputes arising of and touching or relating to the subject matter of this agreement shall be subject to the jurisdiction of local courts of Saharanpur and High Court of Judicature of Allahabad only.
12. All the required T&P and labour shall be arranged by the contractor at his own cost.
13. Any further loss/ damaged during the execution of work shall be born by the contractor at his own cost.
